Freedom of Information Act 2000 – Request for Information

Thank you for submitting a request for information which we received on 4th January 2023 in relation to County Durham and Darlington NHS Foundation Trust (the Trust). Your request has been processed under the provisions of the Freedom of Information Act 2000 and I am now able to provide you with a response.

Your request was in relation to inflammatory bowel disease and I am providing the following information in response to your specific questions:

- 1. The number of patients on the endoscopy waiting list with suspected Inflammatory Bowel Disease**
- 2. The number of patients with suspected Inflammatory Bowel Disease who are waiting more than 6 weeks for endoscopy.**
- 3. The percentage of patients on the endoscopy waiting list with suspected Inflammatory Bowel Disease**
- 4. The percentage of patients with suspected Inflammatory Bowel Disease who are waiting more than 6 weeks for endoscopy.**

The Trust does not centrally record patients on the endoscopy waiting list by suspected diagnosis and estimates that it would take a significant amount of time to gather the information requested. In order to gather this information it would require a member of staff to manually examine the high volume of endoscopy referrals to determine the suspected diagnosis. Therefore, we are refusing this section of your request for information pursuant to section 12 of the Act on the grounds that we estimate that the cost of complying with the request would exceed the appropriate limit. The appropriate limit at the present time is £450.00 which equates to eighteen hours of work by a member of staff at the rate of £25 per hour.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log on the Trust's website. However please be assured that we anonymise all responses prior to adding them to the disclosure log.

I hope that this response has provided you with the information you had requested.
